Themes/topics to be covered under each technical session

A Paradigm Shift in Indian Business Environment

- ① From nationalization to privatization. (Such as banking, disinvestment)
- ② From cooperatives to privates. (Such as sugar industry)
- ③ From local-global to glocal
(Think global-Act local, foreign trade policies, India & WTO, FDI)
- ④ From aided to unaided education
(Such as business education)
- ⑤ From controls to self-regulation
(such as AMFI, AMBI, ASCI, NBA)
- ⑥ From confidentiality to transparency
(such as RTI, Whistleblower Act)
- ⑦ From paperback to net-pack (such as e-commerce, e-books)
- ⑧ Changes in Regulatory, Tax and Legal environment
- ⑨ Changes in India's economic, legal, technological, social, political aspects impacting the business environment
- ⑩ Any other related areas

It is expected that the conference will be an important forum for discussion regarding the selected subject. It will come out with some practical suggestions to keep oneself updated.

Who Can Attend ?

Academic scholars belonging to arts, commerce, management, science, law and information technology including junior and senior college teachers, PG students, industry related scholars etc.

Registration Fees

- Teachers/academicians, industry persons etc. – Rs.1,500/- (with accommodation, Conference kit and a copy of proceedings)
- Teachers/ Academicians – Rs.1,000/- (without accommodation and with conference kit and a copy of proceedings)
- PG students – Rs.500/- (without accommodation and conference kit)
- Breakfast, Lunch and Dinner will be provided to all registered participants.
- If the PG students want the conference kit and a copy of proceedings, they have to pay Rs.1,000 as the registration fees.

Paper Presentation in Absentia

A contributor who cannot attend the conference but wishes to present a paper in absentia is encouraged to send an abstract and the paper as per the above-mentioned schedule. They are eligible to be included in the proceedings. A processing fee of Rs.1,000 will have to be paid for such paper which includes the registration fee for each paper submitted for presentation in absentia.

Best Paper Award

In each session one paper will be selected and awarded as the Best paper.

Submission of research papers

Research papers are invited from the experts on the above mentioned themes. From the papers received along with the registration fee in the form of the DD in favour of 'the Principal, Dayanand College of Commerce, Latur' upto 30th October, 2014, selected papers shall be included in the conference proceedings bearing an ISBN and published by the renowned publisher– Vidyabharti Prakashan. The researchers will have to arrange for their own accommodation if they fail to register before this date.

- * Papers should be original and unpublished, and should not be under publication consideration with any other outlet. Any proposal identical to already published (or substantially same as the one already published) will not be considered. Please include a statement to assure that the work is consistent with these requirements.
- * Papers should include roughly 500 words abstract.
- * In case of joint authorship, all the authors will have to pay the registration fees and at least one author has to attend the conference.
- * Papers should not be longer than 5 double spaced typed pages.
- * Paper size: A-4 in MS-Word Document.
- * Font: Times New Roman, Size: Title 14 points bold, Headings-12 points, Text-10 points (English)
- * Margins: All sides 25.4 mm, Spacing: Single line for text, Two line for headings and paragraphs
- * All paragraphs to start after 5 spaces/ a tab, Print: Laser/Inkjet in Black only
- * Copies: a hard copy and a soft copy in a CD

Location & Places to Visit

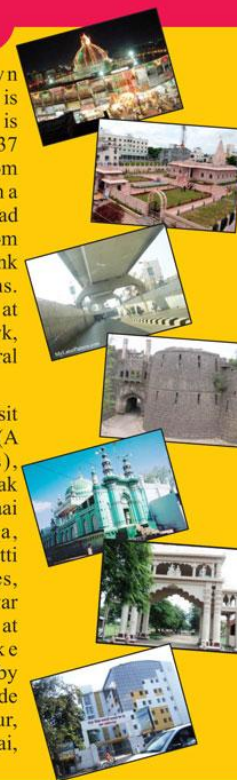
Latur is a well-known educational hub. The nearest airport is at Aurangabad (290 kms), which is connected to Mumbai. Pune is 337 kms and Mumbai is 497 kms from Latur. It is also connected by rail with a station at Latur and Latur Road (broad gauge). State highways and roads from the district headquarters at Latur link all 10 tehsils and major towns. Dayanand Colleges are located at Barshi Road, Near Shivaji Chowk, Latur. It is 2.5 Kms from the Central Bus station.

There are several places to visit within the district, such as Ganjgolai (A connection of sixteen roads), Siddheshwar Temple, Ashtavinayak Temple, Veerat Hanuman Temple, Saai Temple, Suratshahwali Darga, Historical forts of Udgir & AUSA, Hatti Bet (Devarjan), Kharosa Caves, Renukadevi Temple, Nilkantheshwar Temple at Nilanga, Sai Dham at Chakur, Killari Earthquake Rehabilitation Centre etc. The nearby places outside the district include Tuljabhavani Temple at Tuljapur, Yogeshwaridevi Temple at Ambajogai, Vajjnath temple at Parli (V.) etc.

Objective of the Conference

From India's independence, the business sector has undergone a significant change. From a centrally planned economy, with emphasis on public sector units, heavy industries, minimum role of private sector, license raj system, it has shifted to LPG era.
